Shri K. Rahman Khan, Hon'ble Union Minister of Minority Affairs, while addressing the Conference of Principal Secretaries of State/UT on Multi-Sectoral Development Programmes (MsDP) on April 8, 2013 has said, in spite of substantial progress there is a need for more effective implementation of Minority Area Development Programmes during Twelfth Five-Year Plan. Expressing concern over slow progress and lack of proper monitoring, the Minister asked the Officers to monitor regularly the implementation and to timely transfer the Central share of funds released by his Ministry to the concerned District Implementing Agencies.

He said that the benefit has not reached the targeted population. Based on the feedback received from the States and other quarters, his Ministry is restructuring the MsDP. Blocks would be the Unit Area for planning under MsDP in place of Districts and this programme would be further expanded to cover other Towns and Cities. This would sharpen the focus of the programme on the Minorities Concentration Areas and bring other deserving areas like left-out Blocks, Towns and Cities within the ambit of this programme.
